The very essence of our existence is intertwined with the preservation of biodiversity and the sustainability of ecosystems. Currently, we stand at a critical juncture.

On a global scale, terrestrial and marine biodiversity are rapidly decreasing, surpassing the rate of decline seen at any point in human history. Human activities have been responsible for the disappearance of 83% of all wild mammals and half of all plant species. This loss poses a direct threat to nature's resilience and, in turn, to our economic wellbeing, as approximately half of the global GDP relies on the services offered by nature. It is vital to recognize that biodiversity and climate are deeply interconnected and of equal importance. Nevertheless, it is noteworthy that only 5% of Fortune 500 companies have established specific biodiversity objectives, in stark contrast to the 83% that have committed to fighting climate change.
