

## Speaker

#### Prof. Frank Baasner

Director, Deutsch-Französisches Institut e.V.



Frank Baasner (born 1957) is Professor at the University of Mannheim and since 2002 director of the Deutsch-Französisches Institut (dfi) in Ludwigsburg.

Following studies in Germany, Italy, Spain and France he was appointed professor for romance literatures and languages at the University of Erlangen in 1992 and University of Mannhein in 1995. His areas of speciality are cultural history in France, Italy and Spain and comparative cultural studies. He has been visiting professor at the Universities of Valencia, Salzburg and Linköping. In 2003 he became a fellow of the Academy of Sciences

and Humanities in Mainz.

Since 1995 he has been active as an intercultural adviser for well-known French and German companies involved in cross-border cooperation.

The Deutsch-Französisches Institut (dfi) is a research institute specialising in Franco-German relations and contemporary France. Through its research projects, library and press archive it offers a comprehensive range of services for both public and private decision-makers in the field of Franco-German relations: Expert information, consulting for management and human resources, intercultural training.

#### **Patrick Brandmaier**

Chief Executive Officer of the Franco-German Chamber of Industry and Commerce



Patrick Brandmaier has been Chief Executive Officer of the Franco-German Chamber of Industry and Commerce based in Paris since June 2019.

After completing his studies in "International Business Administration" at the universities of Marburg and Vienna with stays abroad in the USA and France, he began his professional career in 1997 at Siemens AG in Munich.

After a career spanning more than 20 years in various management positions at Siemens in Germany, France and Norway, the native German from Karlsruhe moved from Oslo in Norway to the French capital.

Patrick Brandmaier has been connected to France for more than 25 years through his studies, his professional experience and his family situation and lives with both cultures on a daily basis. Franco-German relations have shaped him both professionally and privately and therefore predestine him for his new task at the Franco-German Chamber of Industry and Commerce.

#### Prof. Raja Chatila

Chair, IEEE Global Initiative on Ethics of Autonomous and Intelligent Systems Prof. emeritus, ISIR – Institute of Intelligent Systems and Robotics, Sorbonne Université



Raja Chatila is Professor Emeritus of Artificial Intelligence, Robotics and IT Ethics at Sorbonne University in Paris. He is former director of the SMART Laboratory of Excellence on Human-Machine Interactions, of the Institute of Intelligent Systems and Robotics (ISIR) in Paris, and of Laboratory of System Analysis and Architecture (LAAS-CNRS) in Toulouse, France.

He is author of about 180 publications on autonomous robotics, perception, humanrobot interaction, machine learning, cognitive architectures, and AI ethics. He is chair of the IEEE Global Initiative on Ethics of Autonomous and Intelligent Systems, co-chair of the Responsible AI working group of the Global Partnership on AI and member of the French National Pilot Committee on Digital Ethics (CNPEN).

He is past president of the IEEE Robotics and Automation Society (2014-2015), IEEE Fellow and recipient of the IEEE Robotics and Automation Society Pioneer Award.

#### Sylvie Goulard

Ministry of Foreign Affairs and President, Deutsch Französisches Institut e.V.



Sylvie Goulard is today one of the most important voices in France who consistently advocates for European integration and Franco-German relations. She lives in Paris, is married and has three children. In addition to her native French, she speaks fluent German, Italian, and English.

Her career began in 1989 in the legal department of the French Ministry of Foreign Affairs, where she worked on European law. She had the great fortune to work in the group that negotiated the German reunification and helped prepare the "2+4 Treaty" of September 12, 1990.

Since January 2018, she has been Vice Governor of the Banque de France (mainly responsible for EU issues as well as G7/G20/IMF).

#### Sergio Roberto Gratteri

Founder & Artistic Coordinator "Das Haus" Brussels



Shortly after his studies of musicology and cultural management at the Universities of Leuven (BE), Venice and Rome (IT), he developed his professional career in the field of cultural programming and Art mediation with organizations such as the International Yehudi Menuhin Foundation, Europalia, Interpreti Veneziani (It), De Pianofabriek and La Monnaie.

As coordinator of Audience Engagement Music and Transversal projects at BOZAR he developed new engagement concepts to attract new audiences for classical, jazz and world music by working with renowned orchestras and artists such as the Mahler Chamber Orchestra, London Symphony Orchestra, Joyce di Donato, Jazz Lincoln center.

Always looking for innovative and interdisciplinary models he has developed and/or coprogrammed a.o. the Bozar Music Opening Night, the Big Bang Festival and the United

Music of Brussels project, a unique collaboration between BOZAR, La Monnaie and the NOB. In 2021 he launched DAS HAUS, a new Brussels performance space concept dedicated to innovative classical music projects. Inspired by his strong belief that art is a powerful tool for social cohesion, he has conceived and coordinated maior urban projects such as Singing Brussels, Homelands, Places of belonging and Sounds for the Soul.

As a freelance curator and dramaturge, he regularly accompanies festivals, music ensembles and European cultural institutions such as Esch 2022 Capital of Culture (LU) in defining new strategies of mediation with the public and in setting up refreshing models of artistic programming.

#### Dr. Stefan Hartung

Chairman of the Board of Management, Robert Bosch GmbH



Dr. Stefan Hartung has been chairman of the board of management of Robert Bosch GmbH and a shareholder of Robert Bosch Industrietreuhand KG since January 1. 2022. His responsibilities include corporate strategy, corporate communications and governmental affairs, and technology development. He is also responsible for corporate research and advance engineering, corporate quality management, and the corporate department Technology Manufacturing. In addition, he is responsible for the Bosch Healthcare

Solutions GmbH subsidiary and Bosch operations in China.

Born in Dortmund on January 13, 1966, Stefan Hartung is married and has two children. He studied mechanical engineering, specializing in manufacturing technology, at RWTH Aachen, where he also submitted his PhD (Dr.-Ing.) in 1993.

He joined Bosch und Siemens Hausgeräte GmbH in Munich in 2004. Before that, he worked for the Fraunhofer Society and the management consultants McKinsey & Company in Düsseldorf.

#### Dr. Hans-Dieter Lucas

Ambassador of the Federal Republic of Germany in France



Ambassador Dr. Hans-Dieter Lucas was born in Jülich, North Rhine-Westphalia and studied History, Political Science, Law, and Catholic Theology in Bonn and Paris. He joined the Foreign Service in 1985, which initially led him to the Political Department of the Foreign Office in Bonn and to the German Embassy in Moscow in 1989. At the same time, he obtained his doctorate from the University of Bonn with a thesis on European policy and European thinking during the de Gaulle era in France.

From 1995 to 1998, he was head of the personal office of former Foreign Minister Hans-Dietrich Genscher and subsequently headed the speechwriting staff of Foreign Minister Klaus Kinkel before moving to the German Embassy in Washington as press spokesman. After further assignments in the Chancellor's Office and the Foreign Office, Hans-Dieter Lucas represented the Federal Republic of Germany as Ambassador in the Political and Security Committee (PSC) of the European Union in Brussels from 2010 to 2011.

From 2011 to 2015, he was Director-General for Political Affairs at the Foreign Office. Most recently, Ambassador Lucas was head of the Permanent Representation of the Federal Republic of Germany to NATO from 2015 to 2020. He took up his post as Ambassador of the Federal Republic of Germany to France on September 1, 2020.

#### Gilles de Margerie

Commissioner General, France Stratégie



Gilles de Margerie was appointed as the Commissioner General of France Stratégie, the think tank associated with the office of the French Prime Minister, by the Council of Ministers on January 12, 2018. Prior to this, Gilles de Margerie served as the Chief of Staff to the Minister of Health, Agnès Buzyn, and worked in the public sector for nearly ten years. Initially, he served in the financial regulatory authority and then in the cabinets of Roger Fauroux, the former Minister of Industry and Spatial Planning, and former French Prime Minister Michel Rocard, In addition. he worked in the corporate sector, notably at the French bank Crédit Agricole. From 2013 to 2017, he served as the Deputy CEO of "Humanis," a social protection conglomerate based on equality.

In parallel, Gilles de Margerie founded "En temps réel" in 2000, a think tank that brings together academics, elected representatives, and civil society representatives to capture new regulations, societal changes. and globalization demands. In 2011, he founded the Fondation pour les sciences sociales, which supports research in all areas of social sciences and contributes to their dissemination. As a former student of the École Normale Supérieure and the École Nationale d'Administration, he obtained the "Agrégation" in social sciences.

#### Nils Minkmar writer



Nils Minkmar, born in 1966 in Saarbrücken, holds both German and French passports. His grandparents lived in Bordeaux. He was a editor for the ZDF program "Willemsens Woche" and wrote for almost all major German newspapers, including "Die Zeit", "Frankfurter Allgemeine Sonntagszeitung", "Frankfurter Allgemeine Zeitung", and "Der Spiegel". Since 2020, he has been a freelance author for the "Süddeutsche Zeitung"

and writes the Sunday newsletter "Der siebte Tag".

He was named "Culture Journalist of the Year" in 2006, 2012, and 2017. In 2021, the French Minister of Culture appointed him Chevalier de l'Ordre des Arts et des Lettres.

#### Andreas Schaal

Director for OECD Global Relations and Co-operation and OECD Sherpa to the G7, the G20 and APEC



Mr. Andreas Schaal is the Director for OECD Global Relations and Co-operation, as well as the OECD Sherpa to the G7, the G20 and APEC. In these functions, he supports and co-ordinates the OECD's contributions to global governance under the leadership of OECD Secretary-General Mathias Cormann. In close coordination with OECD Members and the OFCD's External Relations Committee, he and his team implement the OECD Global Relations Strategy, engaging with over 100 partner countries around the alobe at the ministerial level and building a global level playing field by increasing adherence to OECD standards and policies.

Andreas' expertise includes two decades of conceptional and strategic work on foreign affairs, national, international and global economic policy, and global governance. He is responsible for the OECD's relations with Brazil, China, India, Indonesia and South Africa as well as with Southeast Asia. Latin America and the Caribbean, South East Europe, Eurasia, and the Middle East and North Africa. The OECD Global Relations Secretariat, which he oversees and manages, includes around 100 team members. Under Andreas' leadership, it supports the Secretary-General's objectives for a regionally inclusive and globally relevant Organisation.

Francois Venet Member of the Board, Air Liquide



François Venet is currently Senior vice President, Strategy Vice President, based in Frankfurt. He supervises the Large Industries business line and Engineering & Construction. François Venet began his career with Air Liquide as a **Development Engineer and** then a Product Manager before moving to the United States in 1992 to hold various management positions in Air Liquide's U.S. operations, including Senior Vice President for the Industrial Merchant Business Unit.

In 2002, François Venet returned to the Group's headquarters and served as Vice President for Acquisitions, Strategy and Operations Control. In 2005, he was appointed Vice President for European Integration and Development, responsible for Central European industrial functions. He moved to Frankfurt in 2007 to lead the newly acquired Lurgi Group, an engineering company. In 2011, he was appointed Vice President of Engineering & Construction.

In 2013, François Venet was appointed Executive Vice President for Asia Pacific Zone.

In 2015, he was appointed Executive Presidnet of the Shanghai Hub, leading operations in Asia Pacific.
